As you may have noticed, the training calendar has a different look. Trainings are no longer being offered in each county, every month. Providers may attend trainings in other counties from which you live.




Beginning July 1, 2005, we will require a five

participant minimum registration in order to hold a training session.

It is essential that you call to pre-register for classes no later than noon, the day before the training is to be held.

If there are not 5 people registered by Noon the day before the training, the session will be cancelled and those that did register will be notified by phone of the cancellation.

Also as of July 1, 2005, all training must be WV S.T.A.R.S. approved.

STARS Provides Professional Benefits

The West Virginia State Training and Registry System (STARS) is a comprehensive system that supports professional development experiences for all those working to provide quality early care and education opportunities to our state's children. STARS is available to all early care and education professionals working in a variety of settings- child care centers, private and public preschools, Head Start programs, family child care homes and facilities, early intervention programs, school-age child care programs, parent education opportunities, regulatory agencies, and trainers .

One main component of STARS is the Career Pathway. This pathway identifies eight levels of qualifications, credentials, and degrees. When a person registers with STARS, he/she will be recognized at a level based on educational preparation and experience requirements. The pathway is designed to be inclusive of all abilities, from those just beginning in the field to those with more advanced experiences. The Career Pathway applies to all early care and education professional roles: teachers, assistant teachers, aides, directors, administrators, and agency personnel.

Once credentialed, the person's professional information will be entered into a database registry. In order to maintain a accurate and valid registry, it is necessary for everyone to renew the credentialing certificate every 3 years. To remain on the career pathway, each person must complete 45 hours of professional development within the three years. By doing so the person continues their education and professional growth. Moving up the career pathways requires advancement in educational level and/or work experience.

Another main component of STARS is a

trainer approval and registered training system. This system ensures that trainers are qualified to provide training in early care and education content areas. Trainers use the West Virginia Core Knowledge and Core Competencies to register trainings with specific content area(s), learning outcomes, and descriptions. Participants attend or provide these STARS approved trainings in order to meet the required 45 hours of training for renewal.

Because the registry database provides the state with a data source of all early care and education practitioners, certified trainers and registered trainings, there are many benefits to registering with STARS. Through STARS practitioners receive recognition for their professional preparation and experience. It is a tangible and visual recognition of one's accomplishments. This leads to a professional image to parents and the community. In addition, the career pathway can be used to market professional qualifications and to set career goals.

There are also benefits of STARS to program administrators. The career pathway can assist in keeping an updated record of training,, serve as a tool in working with parents and/or governing boards in setting rates, establish wage scales, help in hiring, and facilitate planning for staff development. This data source is a valuable tool for planning, policymaking, and funding programs.

Thousands in the state have already recognized the benefits of using the STARS Career Pathway. By doing so, the early care and education workforce enhances their skills and career opportunities. STARS participants are becoming better equipped to help the families and children of West Virginia succeed.

Change?

Isn't that a difficult word to read? In our society, people don't always like to think about it. In fact, most individuals would prefer to just keep everything the way it is. But sometimes 'change' can be good. And we believe that this is one of those times.

The DHHR department of Early Care & Education has developed NEW "Components of Quality Care & Education" modules for trainers to use with child care providers across the state of WV. They have been created to help educate all providers and offer them more resources for the children in their care. The materials being taught will focus on 2 1/2 - 5 year old children. Each 'module' is basically a 4-hour long training.

There are 8 modules in all for a total of 32 hours in training. The entire 32 hour set of modules will be offered by each MountainHeart trainer at least once a year.

32 Hours?

Yes, we acknowledge that family providers are only required 8 hours of trainings a year, facility directors 10 hours and child care center staff 15 hours. However, if you complete the entire 32 hour course, you will receive free resources to use in your child care home, facility or classroom free of charge. Many courses like this require payment just to attend but this course will not only be free of charge, but will give you free goodies as well.

How will they be offered?

Each trainer will look for the most centralized location to offer these trainings. However, if there are an equal number of interested participants from three different counties, the trainer may choose to split up the 8 courses throughout those three counties. This way, every participant will have to travel for some of the trainings.

Also, details are still ongoing to exactly how the entire set of trainings will be offered. Suggestions include:

- One training a week for 8 weeks
- Two trainings a week for 4 weeks

In fact, we would love to hear from you to see what we can do to make it easier for more providers to attend.

What is required?

All participants will need to pre-register in plenty of time for the training. Also, a MountainHeart trainer will provide a pre-visit to your home or center to get an understanding of your child care environment and to assist you with any care-giving questions you may have.

Finally, after the entire 32-hour course is complete, the trainer will then provide a follow-up visit to your home to see how well you are using the information with the children you care for. Remember, you will receive free goodies to use with all of your children!

Can each module be offered individually?

This is a very good (and important) question. Each module is 4 hours in length and can be offered individually upon request.

However, providers are strongly encouraged to participate in the set as a whole for many reasons:

- 1) Two-hour trainings will still be available, however, they will be offered on a more limited basis.
- 2) Free resources will only be given to providers who can attend the entire set of modules.
- 3) This entire set will cover all required trainings for an entire year (with the exception of CPR/First Aid, and Medicine Administration)

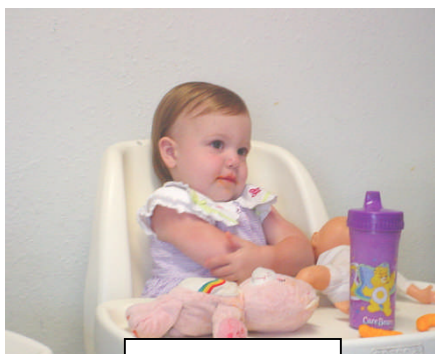
Bobbi will be sadly missed, but not forgotten.

Signing with Daily Activities

Research has proven that children learn while playing within an environment of developmentally appropriate activities. Language is a major part of these daily activities, which include story time, meal time music, and other various learning centers. Sign language can enhance learning for children by seeing and hearing new vocabulary words. Signs are learned more quickly if the children repeat them frequently and are useful to the child in his/her daily routine. Eat, more, sleep, drink, finish, and stop are words that are very useful to most children. A child's vocabulary will increase when repeating signs for colors, animals, or food during story time or communicating for their own wants and needs. It will lower the frustration level for the child and adult.


I want to encourage all providers and teachers to sign with their young children. Starting about the age of seven months with just one or two words and then increasing as the child's ability increases with "recall memory". It is also very important to inform the family of the signs that the child is learning so that they can be used at home with the parents. I am overwhelmed by the response we have had from our providers and teachers that started signing with their young children in their homes or centers in the past nine months that I have been with the TRAILS van. It is very rewarding to see young children learn and grow. I feel very privileged and blessed to work with people who care and love children. I have included pictures of some of the children that are using their hands in Upshur County to learn a new language.

FACTS PLUS

What is FACTS?

FACTS (Family And Children Tracking System) is a large and comprehensive customized Statewide Automated Child Welfare Information System (SACWIS) established by the WV Department of Health and Human Resources (WVDHHR) for the administration of Title IV-E Child Welfare Programs. FACTS was designed and developed based on the requirements established by the U.S. Department of Health and Human Services, Administration for Children and Families, to support the state's federal reporting for Adoption and Foster Care Analysis and Reporting System (AFCARS) and National Child Abuse and Neglect Data System (NCANDS).

What is FACTS PLUS?

FACTS PLUS allows registered Providers to view information about their services provided via Statewide FACTS system.

Who can apply for a FACTS PLUS account?

A FACTS PLUS account is available to all providers, facility and center directors who are currently in the FACTS system.

How much does it cost to have a FACTS PLUS web account?

FACTS PLUS is **FREE** for all providers, facilities and centers.

What are the benefits of using FACTS PLUS?

FACTS PLUS speeds up the sharing of information between the Bureau for Children and Families and the providers. Providers can view information regarding their payments and their clients. For Facilities and Centers several staff can have log on accounts under their Director to access information. Links to important websites.



Where do I get a FACTS PLUS application and confidentiality statement?

1. You can download the application on-line from the FACTS PLUS home page at www.wvfacts.org/factsplusnet
 2. Call your local MountainHeart office and request an application
 3. E-mail your request to the FACTS Help Desk at factshelp@wvdhhr.org
- Remember to give your name and address.

Now that I have the application what do I do next?

1. Complete the requested information. Sign and date the application. (If you have any questions, you can call your local MountainHeart office for help)
2. Read the Confidentially Statement. Sign and date that form.
3. Mail the completed application **and** confidentiality statement to:

In approximately seven to ten days you will receive an e-mail from FACTS PLUS which will include a password and instructions to get you started.

5 Ways to Promote Brain Development

Brain Development is extremely important in children between the ages of 0-3 months. Listed are 5 ways that you can help promote brain development in your baby.

1. Prop the baby up vertically when you are showing him/her a new play object, book, etc. Babies see more clearly when they are held vertically as opposed to being held horizontally.
2. Talking to your baby will give him/her a jumpstart on vocabulary, reading and writing skills. You do not have to limit your talk to a sing-songy manner or “baby” topics. As you go through your day, talk about what you are doing: “We need to go to the grocery store and get some vegetables.” Include the baby in family conversations.
3. Create a stimulating environment. Don’t be afraid of using bold, high-contrast colors and patterns in the baby’s room. Put pictures of letters, animals and numbers around the room, and point to them frequently.
4. Make a book of words and pictures.

Cut pictures from old magazines and clip a few pages of paper together to glue the pictures and words onto. One excellent theme is opposites: a picture of an open door and one of a closed one; a big chair and a small one. Another theme uses rhyming words: pictures of a pan, fan and a can.

5. By six months, you can introduce bigger baby toys such as shape sorters, blocks and stacking cups. Demonstrate how these toys should be played with, but also let your baby explore on his own.

Parents want to know what to look for as children grow, according to Success by 6, a program of United Way of the River Cities. Remember that children grow at different rates, and this checklist is provided only as a guideline for normal growth and development.

Between 0-3 months, most children:

- Lift head and chest when lying on tummy
- Watch things for a short time
- Make sounds in throat
- Do not like to feel a cloth or a blanket

on their faces

- Bob when holding up head
- Copy a smiling person
- Roll part way to side
- Make sounds when uncomfortable
- Lift head when held at shoulder
- Move arms and legs a lot
- Recognize bottle or breast

If you are concerned about your child’s development or growth, ask your doctor, take your child to a preschool screening, or call your local Birth to Three Regional Administrative Unit.
